GUIDELINES FOR AUTHORS

The Journal Ratio Juris from The Universidad Autónoma Latinoamericana School of Law is a publication of academic nature which has wide national and international production and circulation, intended to be a medium of debate, interlocution and socialization for the academic and scientific production of the academic community immersed in legal and socio-legal issues.

This is the reason why The Universidad Autónoma Latinoamericana School of Law invites the international and national communities to submit their articles. Topics should be about Law or related areas such as Legal Sociology, Law History, Legal Philosophy, Legal Psychology and Legal Anthropology. For the presentation of articles, it should be taken into consideration that in the convocation process, priority will be given to those articles close to the following themes and with one of the modalities or typologies of publication here referenced:

THEMES

Law, Latin-american State and Culture.

Globalization, Human Rights, Public Policies.

Subjectivity, Family and Society.

Modalities of articles

The following are the modalities that will prevail for publication.

1) Articles of scientific and technological research. Documents presenting detailed, original results of finished research projects. The structure generally used contains four important segments: Introduction, methodology, results and conclusions.

2) Articles of reflection. Documents presenting results of a finished research project from the analytic, interpretative or critical author's perspective about a specific topic resorting to original sources.

3) Review articles. Document resulting from a finished research in which the outcomes of published or not-published researches are analyzed, systematized and, integrated in the fields of science or technology to inform of the advances or



trends of their development. It is characterized for presenting a careful bibliographic review of at least 50 references.

4) Short article. A brief document presenting preliminary or partial original results of a scientific or technological research that generally demands a prompt diffusion. In the convocation, the author will be the sole responsible for any violation to the authors' rights, so that the Editorial Board of the journal reserves the right to accept and publish reviews of literature, adaptations and translations, cases in which the author's statement should be manifested and the corresponding bibliographic references included. The presentation of an article to the permanent convocation of the Ratio Juris magazine, means:

1. The author welcomes and accepts the established norms in this document for the presentation and evaluation of the articles;
2. He makes the presentation of the written with the express prior authorization of the public or private institution, that finances the elaboration of the proposed text.
3. Expresses its willingness to publish the article, which does not exempt the diligence of the transfer of rights for publication.

The mailing of an article should be adjusted to the following parameters:

1. - Accompanying the article with the constancy, or make clear and explicit mention in the medium of presentation, that is unpublished, of his own and has not been proposed to any other media simultaneously. In addition, transfer their property rights to the institution and authorize it to divulge the article in the physical and virtual medium, and in the databases and bibliographic indexes in which the magazine is indexed to promote open access to the community.
2. Send the article on magnetic medium and/or a printed copy to the journal's editor Jorge Eduardo Vásquez Santamaría: jorge.vasquez@unaula.edu.co

3. The articles must be presented taking into consideration the following structure:
 - Article's title, and subtitle if available, both translated into English, and if possible, into Portuguese.
 - In footnotes indicate the title of the completed research or in the process of which the item is product, line and research group which links the writing, name of the principal investigator and co-investigators, quality in which the author participated,



institution which financed or finances the research, name of research, and year of culmination of the same.

- Full author(s)' name(s), and in a footer note, indicate their academic credentials, institution where they work and research group, e-mail address and mailing address (the latter being information not published, and exclusive to the journal).
- Article's abstract (15 lines maximum) and keywords. Both, translated into English, and if possible, to Portuguese.
- Introduction (general presentation of the article), methodology used in the development of the research project.
- Development of the article.
- Conclusions.
- Bibliographic references according to the APA (American Psychological Association) citation style.

4. The article's layout must comply with to the following statements:

- Letter-size paper, one-sided printed.
- Double spaced paragraphs.
- MS Word file format.
- 12-point Arial font.
- No less than 15 pages long, and no more than 30 pages long.
- APA (American Psychological Association) Reference Citation Style.

5. In a separate sheet, attach the author's résumé, if not a professor at Universidad Autónoma Latinoamericana.

The process to select the articles is as follows:

1. The author(s) send to the e-mail stated in the second numeral, the proposed article to the permanent call.
2. The Editor checks that the requirements expressed are met, both in the forms required for the presentation of the article, and in its structure and components. Verified the optimum fulfillment of the same, the article goes on to the selection of arbitrator (s) evaluator (s), otherwise it will be returned to the author stating the reasons for rejection.
3. The article is made known by the Editorial Committee to conceptualize the appointment of the evaluator referee.
4. The Editor sends the text to the evaluator referee, who is granted a period of 15 consecutive days for the performance of his work, the evaluation format that must



fill is presented and the revision is cleared under de modality of double blind spot.

5. Expired the evaluation term for the selected referee, the concept of this author is exposed, wich includes the decision about the publication of the article, that may be: rejected, accepted, and accepted subjected to the realization of modifications and adjustments.

6. The Editor communicates to the author in the shortest possible time the decision taken.

7. In case of the decision were accept the article subjected to the realization of modifications and adjustments, the editor will consult to the author the volition of continue with the editorial process. In case of result a negative answer by the author, the article is understood like rejected; in case of result a positive answer by the author, a new term of 15 consecutive days is granted to realize the adjustments and modification, and return the new version of the written to the magazine's Editor.

The Journal Ratio Juris assumes no liability for eventual damages suffered during the mailing process or for manuscripts loses; besides, the journal does not assume the responsibility of returning the rejected articles; given this fact, it is important that authors keep their own manuscript copies.

Note: manuscripts are received year-round and their publication date depends upon their arrival date.
